



**Temporary Restricted Area (TRA) in the vicinity of
Druids Glen, County Wicklow,
On Saturday 29th August 2026 to Wednesday 02nd September 2026**

The Irish Aviation Authority in pursuance of Articles 7 & 10 of the Irish Aviation Authority (Rules of the Air) Order, 2019 (S.I. No. 266 of 2019), and in accordance with European Commission Implementing Regulation (EU) No. 923 of 2012, SERA.3145 (Prohibited Areas and Restricted Areas), hereby directs as follows:

Temporary restrictions (Temporary Restricted Areas) on the flying of aircraft and rockets as defined in S.I. No. 25 of 2023, shall apply in the vicinity of the Druids Glen, County Wicklow in the airspace contained within the under mentioned:

Lateral limits:	N531119.38 W0061253.90, N530044.43 W0061306.16, N530041.93 W0055136.44, N531123.37 W0055155.40
Vertical limits:	SFC to 5000FT AMSL
Duration:	Saturday 29 th August 2026 to Wednesday 02 nd September 2026. The period of restriction shall be daily from 0700hrs UTC to 2000hrs UTC.
Controlling Authority:	Department of Justice, Home Affairs and Migration, 51 St Stephens Green, D2, coflight@justice.ie

The Purpose of the TRAs:

The purpose of the TRA is for reasons of security, by the Department of Justice, Home Affairs and Migration in the vicinity of Druids Glen County Wicklow.

Airspace Classification & Communication Service:

The airspace contained within the TRA is classified as ICAO Class C. The TRA is located within the Dublin CTA/Shannon FIR.

Flight Restrictions & Exemptions:

a. Flights Permitted.

- i. State aircraft, aircraft of the Irish Coastguard Service and HEMS Aircraft Operators employed on an operational mission shall be exempt from the restriction including flights authorised by the controlling authority (Department of Justice, Home Affairs and Migration).
- ii. All scheduled commercial arrivals and departures at Dublin Airport are exempt (including MAPs).
- iii. Controlling Authority: Department of Justice, Home Affairs and Migration, 51 St Stephens Green, D2, coflight@justice.ie

b. Flights not permitted.

- i. All other aircraft are not permitted.
- ii. Any exemptions, alleviations, or permissions, other than those listed at '**a. Flights Permitted**' granted to civil general air traffic by the Authority, are not valid within the TRAs during the periods cited.

A NOTAM will be issued in due course by the AIS office to notify of the TRA activation.

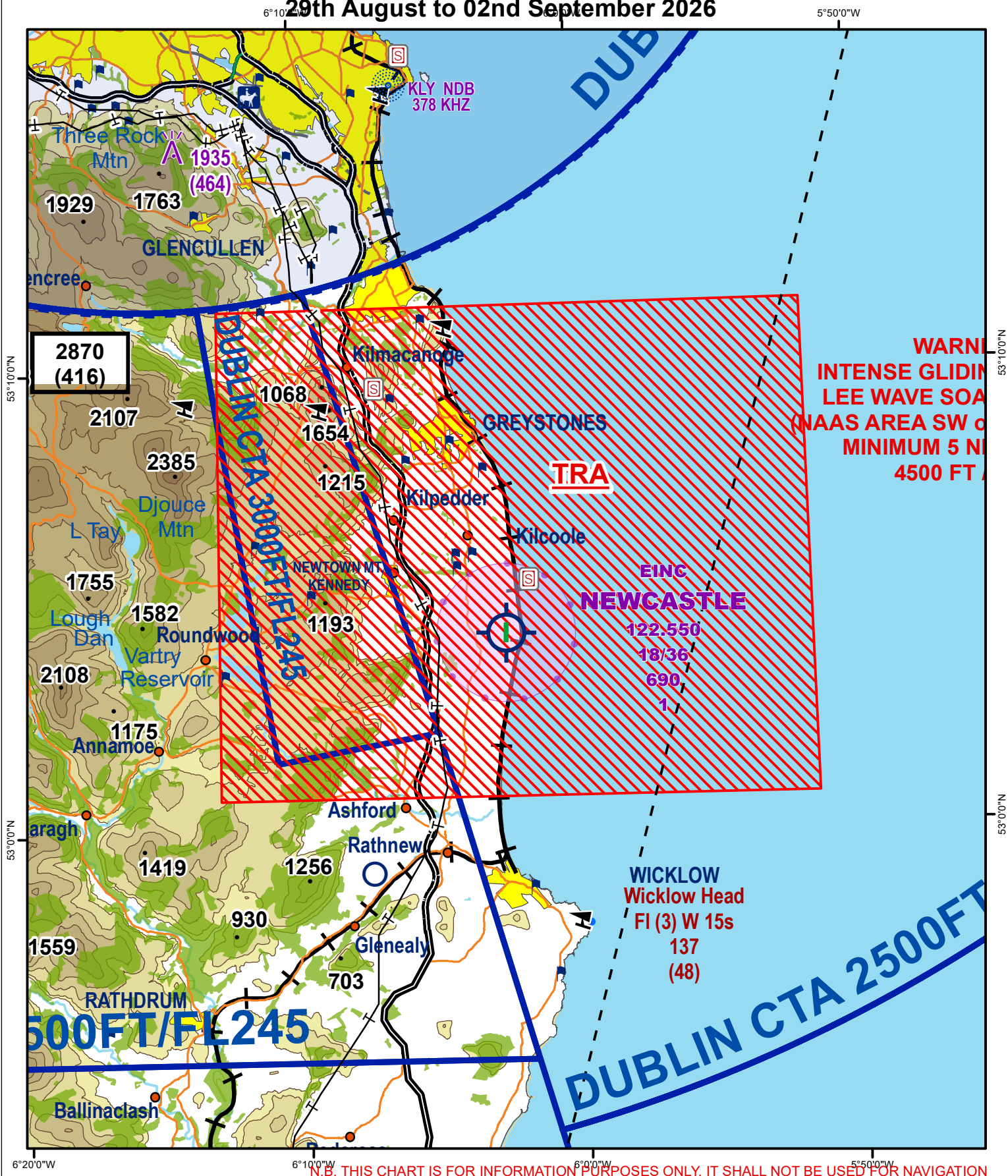

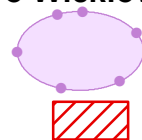
